**CITY ORDINANCE NO. 452, s-2010**

**“AN ORDINANCE FURTHER AMENDING CITY ORDINANCE NO. 139, s-2004 AN ORDINANCE AMENDING CITY ORDINANCE NO. 83, S-2003, AN ORDINANCE CREATING THE POSITION OF SENIOR CITIZENS COORDINATOR ON EACH OF THE 23 BARANGAYS IN THE CITY OF TAGUM AND PROVIDING FUNDS FOR ITS MONTHLY HONORARIA.”**

**BE IT ENACTED** by the Sangguniang Panlungsod of Tagum in session assembled, that:

**SECTION I.** x x x

**SECTION II.** x x x

**SECTION III.** Section 3 of the City Ordinance No. 139, s-2004 which reads:

SECTION III. The amount of One Hundred Fifty Thousand Pesos (P150,000.00) shall be appropriated annually for the monthly honoraria of the Senior Citizen's Coordinator on each of the 23 Barangays in the City of Tagum whose term of office is one year.

Shall be amended to read as follows:

SECTION III. The amount of Three Hundred Thousand Pesos (P300,000.00) shall be appropriated annually for the monthly honoraria of the Senior Citizen's Coordinator on each of the 23 barangays in the City of Tagum whose term of office is one year.

**SECTION IV.** Section IV of the City Ordinance No. 139, s-2004 which reads:

SECTION IV. Each member of the TACIFESCA and the two Federation Advisers shall receive a monthly honoraria of Five Hundred Pesos only (P500.00).

Shall be amended to read as follows:

SECTION IV. Each member of the TACIFESCA and the two Federation Advisers shall receive a monthly honoraria of One Thousand Pesos only (P1,000.00).
