CITY ORDINANCE NO. 463, s-2010

“AN ORDINANCE REVERTING THE AMOUNT OF ONE HUNDRED THOUSAND PESOS (P100,000.00) APPROPRIATED BALANCE TO THE UNAPPROPRIATED BALANCE AND SHALL BE MADE AVAILABLE FOR SUBSEQUENT APPROPRIATION.”

BE IT ENACTED by the Sangguniang Panlungsod of Tagum, in session assembled that:

SECTION I. The amount of One Hundred Thousand Pesos (P100,000.00) appropriated balance from the Human Resource & Management Office - Locally Funded Projects – Provision for Job Order PHILHEALTH Program – MOOE – Other Maintenance & Operating Expenses shall be reverted to the unappropriated balance.

SECTION II. EFFECTIVITY CLAUSE. This ordinance shall take effect immediately upon its approval.
