**CITY ORDINANCE NO. 435, s-2010**

**“AN ORDINANCE REVERTING THE AMOUNT OF THREE MILLION THREE HUNDRED THOUSAND PESOS (P3,300,000.00) APPROPRIATED BALANCE TO THE UNAPPROPRIATED BALANCE AND SHALL BE MADE AVAILABLE FOR SUBSEQUENT APPROPRIATION.”**

**BE IT ENACTED**, by the Sangguniang Panlungsod of Tagum, in session assembled that:

**SECTION I.** The amount of Three Million Three Hundred Thousand Pesos (P3,300,000.00) an appropriated balance of Locally Funded Projects – River Festival (Other MOE) in the amount of Two Hundred Thousand Pesos (P200,000.00), Capital Outlay (Surveillance System) in the amount of One Million Pesos (P1,000,000.00), 20% Development Fund under City Integrated Disease Surveillance Response Unit (Printed Forms) in the amount of Forty Thousand Pesos (P40,000.00) and (Other MOE) in the amount of Sixty Thousand Pesos (P60,000.00), Continuing Appropriation Allotted (2009) under Capital Outlay – Surveillance System in the amount of Two Million Pesos (P2,000,000.00), under the Executive Department shall be reverted to the unappropriated balance.

**SECTION II. EFFECTIVITY CLAUSE.** This ordinance shall take effect immediately upon its approval.
