CITY ORDINANCE NO. 138, S-2004

“AN ORDINANCE GRANTING BURIAL ASSISTANCE TO SENIOR CITIZENS OF TAGUM CITY AND APPROPRIATING FUNDS FOR THE PURPOSE.”

BE IT ENACTED by the Sangguniang Panlungsod of Tagum in session assembled, that:

SECTION 1. *DECLARATION OF POLICY.* Pursuant to RA 7432 Section 10, that the State shall provide social justice in all phases of nation development for Senior Citizens.

SECTION 2. *DEFINITION OF TERMS.* Senior Citizen – those who have reached the age of sixty (60) and above and have officially filed his/her application with the City Social Welfare and Development Office under RA 7432 with an official identification (ID) duly registered with the CSWDO, Tagum City.

SECTION 3. *QUALIFICATION.* Shall in accordance with the following policies as prescribed by Tagum City Federation of Senior Citizens Association. In case of death the legitimate beneficiary concerned is entitled to Five Thousand (P5,000.00) Pesos burial assistance with the following requirements, to wit:

- a. Certification from the corresponding Barangay Senior Citizens Coordinator, as bonafide member of the Association;
- b. Photo copy of Death Certificate authenticated by the Civil Registrar of Tagum City;

- d. If the bonafide member of the association is also a barangay official and barangay functionary, burial benefit shall be claimed by said member whichever is higher as based on the benefits as stated in City Ord. No. 34, s-2002, as amended by City Ord. No. 108, s-2003.

SECTION 4. SOURCE OF FUNDS. That the Office of the City Mayor shall appropriate an amount intended for the said purpose and such budget may be increased or augmented as recommended by the OSCA Chairman and/or City Social Welfare Development Office, this city.

SECTION 5. EFFECTIVITY CLAUSE. That this ordinance shall take effect immediately upon approval.
