**CITY ORDINANCE NO. 320, S-2008**

**“AN ORDINANCE IMPOSING THE REGULATION OF FARE RATES OF MOTORIZED TRICYCLE FOR HIRE (MTH) OF THE CITY OF TAGUM.”**

**BE IT ORDAINED** by the Sangguniang Panlungsod of Tagum City in session assembled that;

**SECTION 1. TITLE** - This Ordinance shall be known as, “An Ordinance imposing the Regulation of Fare Rates of Motorized Tricycle for Hire (MTH) in the City of Tagum.”

**SECTION 2.** The Transportation plays a vital and significant role in our economy in the movement of goods and products and more particularly in the movement of individual/s or public in the delivery of its services.

**SECTION 3.** The Tricycle Sector in the City of Tagum represents the biggest number of public transportation in developing and promoting inter-modal and strategic transportation that are reliable, responsive and viable service to the public.

**SECTION 4.** And that due to the fluctuating prices of Gasoline per liter, it is but proper that the fare rates of said Motorized Tricycle for Hire (MTH) shall be based on the price rates of Gasoline per liter in Tagum City as follows:

<b>P 20.00 – 29.99</b>	<b>P 6.00</b>	<b>P 4.00</b>
<b>30.00 – 39.99</b>	<b>7.00</b>	<b>5.00</b>
<b>40.00 – 49.99</b>	<b>8.00</b>	<b>6.00</b>
<b>50.00 – 59.99</b>	<b>9.00</b>	<b>7.00</b>
<b>60.00 – 69.99</b>	<b>10.00</b>	<b>8.00</b>
<b>70.00 – 79.99</b>	<b>11.00</b>	<b>9.00</b>
<b>80.00 – 89.99</b>	<b>12.00</b>	<b>10.00</b>
<b>90.00 – 99.99</b>	<b>13.00</b>	<b>11.00</b>
<b>100.00 &amp; up</b>	<b>14.00</b>	<b>12.00</b>

- The above rates are the specified fare rates within the first three (3) kilometers of the Central District from where the passengers originated, however an additional of P1.00 for every kilometer or every fraction thereof.

**SECTION 5.** The City Tricycle Franchising and Regulatory Board (CTFRB) of this City is responsible in implementing the provision under Section 4 of this Ordinance through its Board Resolution.

**SECTION 6. REPEALING CLAUSE** – Any Ordinance/s, Resolution/s or parts thereof inconsistent herewith are hereby repealed accordingly.

**SECTION 7. EFFECTIVITY CLAUSE** – This Ordinance shall take effect immediately upon approval
