CITY ORDINANCE NO. 218, S-2006

“AN ORDINANCE ADOPTING THE REVISED SCHEDULE OF MARKET VALUES OF REAL PROPERTIES IN THE CITY OF TAGUM INCLUDING THE ASSESSMENT LEVELS AS PROVIDED FOR UNDER SECTION NO. 218 OF REPUBLIC ACT 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991.”

BE IT ENACTED by the Sangguniang Panlungsod of Tagum in session assembled, that:

SECTION 1. That the new Schedule of Market Values of Real Properties in the City of Tagum including the Assessment Levels, be read as follows:

SECTION 2. SEPARABILITY CLAUSE – That should any portion of this ordinance be declared unconstitutional or illegal by any court of competent jurisdiction, those parts which are not so declared shall remain in full force and effect.

SECTION 3. REPEALING CLAUSE – That all other ordinances, resolutions, orders and issuances contrary to this ordinance are hereby repealed or superseded accordingly.

SECTION 4. EFFECTIVITY CLAUSE – That this ordinance shall take effect immediately upon approval.
