“AN ORDINANCE AMENDING CHAPTER 2, SECTION 4 AND CHAPTER 4, SECTION 9 OF THE CITY ORDINANCE NO. 307, S- 2008, AN ORDINANCE CREATING THE TAGUM CITY CONSUMER WELFARE AND PROTECTION COUNCIL.”

BE IT ENACTED by the Sangguniang Panlungsod of Tagum in session assembled:

SECTION I. That Chapter 2, Section 4 of City Ordinance No. 307, s-2008, which reads as:

SECTION 9. To defray the operational expenses necessary for the effective implementation of this ordinance, funds shall be sourced out from the annual budget of the city government annually in the sum of Two Hundred Thousand **(P 200,000.00)** Pesos.

SECTION III. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon its approval.
