**RESOLUTION NO. 409, s-2008**

**A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. REY T. UY, TO ENTER INTO AND SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF TAGUM A MEMORANDUM OF AGREEMENT (MOA) WITH THE REGIONAL TRAINING CENTER (RTC) KOREA-PHILIPPINES (KOR-PHIL) VOCATIONAL TRAINING CENTER, REPRESENTED BY ITS OIC CENTER ADMINISTRATOR, EGMEDIO O. VALDEZ, JR.**

**WHEREAS**, a communication dated 04 July 2008 of Hon. Rey T. Uy, City Mayor, addressed to the Sangguniang Panlungsod, endorsed the Memorandum of Agreement between the City Government of Tagum and the Regional Training Center (RTC) Korea-Philippines (Kor-Phil) Vocational Training Center;

**WHEREAS**, the City Government of Tagum committed to put premium on education as its priority thereby committing its support especially to the programs that would help the students more effective and productive;

**WHEREAS**, the City Government of Tagum established the City Vocational Technical Educational Scholarship Program (CIVOTESPRO) in order to provide easy access on technical vocational education and to open opportunities for our determined and deserving pupils and students who do not have sufficient means for schooling;

**WHEREAS**, Regional Training Center/the Korea-Philippines Vocational Training Center was established to provide training to the underprivileged but potential youths and adults to acquire highly demand skills local and abroad;

**WHEREAS**, both parties share a common vision of helping the targeted beneficiaries improve their economic condition and expressed willingness to follow all the agreements stipulated in the Memorandum of Agreement (MOA);

**NOW THEREFORE**, be it resolved by the 4<sup>th</sup> City Council of Tagum to authorize the City Mayor, Hon. Rey T. Uy, to enter into and sign for and in behalf of the City Government of Tagum a Memorandum of Agreement (MOA) with the Regional Training Center (RTC) Korea-Philippines (Kor-Phil) Vocational Training Center by its OIC Center Administrator, Egdemio O. Valdez, Jr.

**RESOLVED FURTHER**, that the full text of the Memorandum of Agreement shall be as follows:

### **MEMORANDUM OF AGREEMENT**

#### **KNOW ALL MEN BY THESE PRESENTS:**

This Agreement executed and entered into this 2<sup>nd</sup> day of July, 2008 at Tagum City, Davao del Norte, Philippines, by and between:

The CITY GOVERNMENT OF TAGUM with principal office at City Hall, City of Tagum, Davao del Norte, Philippines, represented by City Mayor, Hon. REY T. UY, hereinafter known as the City Government of Tagum;

-and-

The REGIONAL TRAINING CENTER (RTC)/KOREA-PHILIPPINES (KOR-PHIL) VOCATIONAL TRAINING CENTER with principal office at Buhisan, Tibungco, Davao City, Philippines, represented by the Office-In-Charge-Center Administrator, Mr. EGMEDIO O. VALDEZ, JR., hereinafter known as RTC/KOR-PHIL Vocational Training Center.

-WITNESSETH-

WHEREAS, one of the primary objectives of the City Government of Tagum is human resource development which can be attained through quality formal education and/or training in the field of industrial skills and technology thereby equipping its constituents with skills for wage employment; self-employment and/or entrepreneurship;

WHEREAS, in order to uplift the economic condition of marginalized sector consisting of farmers and farmer's children, cooperative farm workers, unskilled corporate farm workers, unemployed retrenched workers, out-of-school-youth, college dropout, and unemployed adults, the LGU has established the City vocational Technical Educational Scholarship Program (CIVOTESPRO);

WHEREAS, Regional Training Center/the Korea-Philippines Vocational Training Center was established to provide training to the underprivileged but potential youths and adults to acquire highly demand skills local and abroad;

WHEREAS, the parties hereto share a common vision of helping the targeted beneficiaries improve their economic condition and committed to pool their resources and expertise for human resources developments;

NOW THEREFORE, in consideration of the foregoing premises, and of mutual governance and stipulation hereinafter set forth, the parties agree as follows:

#### 1. OBLIGATION OF THE PARTIES

A. The CITY GOVERNMENT OF TAGUM shall:

1. Ensure the enrolment of fifty (50) scholars under the City Vocational Technical Educational Scholarship Program to take up one year training courses being offered at the RTC/Kor-Phil Vocational Training Center for a training period of one year.

2. Provide the monthly payment of the scholars, dormitory fees and a stipend of Php 500.00 per month.
  3. Monitor the training status and progress of the students of the grantees enrolled at the RTC/KOR-PHIL Vocational Training Center.
- B. The RTC/KOR-PHIL Vocational Training Center shall:
1. Provides fifty (50) slots comprising the various one-year vocational courses offered by the Center to accommodate the grantees of Tagum City Vocational Educational Scholarship Program (CIVOTESPRO) grantees;
  2. Facilitates the conduct of qualifying examination and interview of the grantees;
  3. Provides the city government updates regarding the training status and progress of the grantees enrolled at the Center;
  4. Ensures the effective and efficient conduct of training/instruction in both on-the-job venue and in-center;
  5. Administer to each trainee the appropriate skills assessment/test at the end of each competency module and issue the certificate of competencies at the end of training course or earlier when need for purpose (but listing only those competencies passed);
  6. Issue the appropriate training certificates (co-signed by the sponsoring partner) at the end of the training terms;
  7. Assists in the job placement of trainees/graduates;
  8. Issue Official Receipt in favor of the City Government of Tagum for all the fees received; and
  9. Perform other functions that will ensure the success of the program.

11. AMENDMENT

The Parties hereto may, upon consent, amend or modify this agreement or through an addendum in writing duly signed by the herein parties.

111.EFFECTIVITY

This Agreement shall take effect upon the beginning of the School Year 2008-2009 and thereafter and shall remain in full force unless terminated by mutual consent between the parties.
