**A RESOLUTION CONFIRMING RESOLUTION NO. 08, SERIES OF 2008 OF THE CITY DEVELOPMENT COUNCIL (CDC), A RESOLUTION ENDORSING TO THE SANGGUNIANG PANLUNGSOD AN AMENDMENT BY INCLUSION OF VARIOUS PROJECTS IN THE AIP 2008 UNDER THE LOCALLY FUNDED PROJECTS AND 20% DEVELOPMENT FUND.**

**WHEREAS**, presented before the Sangguniang Panlungsod is Resolution No. 08, series of 2008 of the City Development Council regarding the approval of the proposed inclusion of various projects under the Locally Funded Projects and 20% Development Fund in the AIP for CY 2008 of the city government, to wit:
