RESOLUTION NO. 419, s-2008

“A RESOLUTION CONFIRMING BARANGAY ORDINANCE NO. 02, SERIES OF 2008 OF THE SANGGUNIANG BARANGAY OF NUEVA FUERZA, TAGUM CITY.”

WHEREAS, presented to this august body the Barangay Ordinance No. 02, series of 2008 of the Sangguniang Barangay of Nueva Fuerza, Tagum City, “An Ordinance authorizing Hon. Celedonia M. Mamayabay, Punong Barangay to augment the appropriation of Repair and Repaint of Barangay Hall in the amount of Twenty Thousand (P20,000.00) Pesos, Office Supplies in the amount of Five Thousand Five Hundred (P5,500.00) Pesos, Electricity in the amount of Five Thousand (P5,000.00) Pesos, Fuel in the amount of Six thousand (P6,000.00) and other MOOE in the amount of Three Thousand Five Hundred (3,500.00) Pesos only, for appropriate action;
