RESOLUTION NO. 437, s-2008

“A RESOLUTION APPROVING THE APPLICATION FOR ACCREDITATION OF KATIPUNAN NG MGA KASAMA KABARKADA KAPUSO KAPAMILYA PARA SA KAUNLARAN, INC. AS NON-GOVERNMENT ORGANIZATION IN THE CITY OF TAGUM.”

WHEREAS, Article 62, Rule XII of the Implementing Rules and Regulations of the Local Government Code of 1991 provides that the LGU shall promote the establishment and operation of people’s organizations, non-government organizations and the private sector to make them active partners in the pursuit of local autonomy;

WHEREAS, in furtherance of law and policy relative to the participation of non-government organization in the promotion of the participatory local governance and in the pursuit of local autonomy, DILG MC No. 2001-89 provides for the guidelines and procedure in the accreditation;

WHEREAS, the Katipunan ng mga Kasama Kabarkada Kapuso Kapamilya para sa Kaunlaran, Inc. has manifested its intent to acquire legal recognition from the city government as embodied in its Board Resolution No. 1-5, s-08 along with its application for accreditation attested by Chairman, Perfecto Cadullo;

WHEREAS, after thorough review of the documents submitted to this august body per Committee Report No. 13, s-2008 of the Committee on Government Organizations, Non-Government Organizations and Cooperatives, the Katipunan ng mga Kasama Kabarkada Kapuso Kapamilya para sa Kaunlaran, Inc. has substantially complied with the requirements for accreditation;

NOW THEREFORE, be it resolved by the 4th City Council of Tagum City, to approve the application for accreditation of Katipunan ng mga Kasama Kabarkada Kapuso Kapamilya para sa Kaunlaran, Inc. as Non-Government Organization in the City of Tagum for a provisional period of six (6) months.

RESOLVED FURTHER, that copies of this resolution be furnished to the Katipunan ng mga Kasama Kabarkada Kapuso Kapamilya para sa Kaunlaran, Inc. and all offices concerned for their information and guidance.
