**WHEREAS**, the Office of the City Mayor has endorsed the application of Glorious Resurrection Memorial Park, Inc., represented by Mr. Jesus M. Iape, for alteration on the approved plan on August 13, 2008 to this august body;

**WHEREAS**, the Sangguniang Bayan of Tagum has passed and approved Resolution No. 230, s-1971 granting Glorious Resurrection Memorial Park, Inc. to put their establishment within the Municipality of Tagum as per verification made by the body on the development plan;

**WHEREAS**, the alteration on the approved plan is intended to cater the demand for family estate;
