**RESOLUTION NO. 485 s-2008**

**“A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF TAGUM A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE NATIONAL POLICE AND THE MOUNTAIN CLARK FIRING RANGE AND GUNSMITH.**

**WHEREAS**, Section 2 of RA 6975 stipulates that it is the policy of the State to promote peace and order, ensure public safety and further strengthen local government capability aimed towards the effective delivery of basic services to the citizenry through the establishment of a highly efficient and competent police force that is national in scope and civilian in character;

**WHEREAS**, among the powers and functions of the PNP is to maintain peace and order and take all necessary steps to ensure public safety;

**WHEREAS**, the Armalite Rifles refurbishing/conversion are seventeen (17) units commando;

**NOW THEREFORE**, be it resolved by the 4<sup>th</sup> City Council of Tagum to authorize the City Mayor to sign for and in behalf of the City of Tagum a Memorandum of Agreement with the Philippine National Police and Mountain Clark Firing Range and Gunsmith.

**RESOLVED FURTHER**, that the full text of the Memorandum of Agreement shall be as follows:

**MEMORANDUM OF AGREEMENT**

**KNOW ALL MEN BY THESE PRESENT:**

This AGREEMENT is made and entered into by and among:

The CITY GOVERNMENT OF TAGUM, a Local Government Unit organized and existing under the laws of the Republic of the Philippines, with principal office address at the City Hall, Rizal St., Tagum City, Davao del Norte, represented in this act by the City Mayor, HON. REY T. UY, in full execution of the authority granted upon him, and hereinafter referred to as “Party No. 1;

The PHILIPPINE NATIONAL POLICE, a government agency created and existing by virtue of and pursuant to Republic Act 6975, as amended by RA 8551, its national Headquarters located at Camp Crame, Quezon City, represented herein by Police Director CHARLEMAGNE S. ALEJANDRINO, CSEE, Director for Logistics, PNP, and hereinafter referred to as “Party No. 2;

The MOUNTAIN CLARK FIRING RANGE AND GUNSMITH, a private company duly registered as single proprietorship before the Department of Trade and Industry with principal office address at 15-29 Don Jose Street, Don Bonifacio Subdivision, Balibago, Angeles City, represented herein by Mr. Ricardo M. Chu, Proprietor/General Manager, and hereinafter referred to as "Party No. 3".

WITNESSETH, That:

WHEREAS, Party No. 2 has an inventory of Armalite Rifles due for repair;

WHEREAS, due to fiscal crisis, Party No. 2 has no funds to repair or refurbish the aforementioned rifles;

WHEREAS, Party No. 1 undertakes to shoulder the expenses for refurbishing/conversion of aforementioned M16 Rifles at NO COST TO THE PNP for the eventual use of the Tagum City Police Station;

WHEREAS, Party No. 3 has the expertise and experience to refurbish/convert the aforementioned rifles;

NOW THEREFORE, for and in consideration of the above premises, the parties hereby agree to undertake the following, to wit:

1. That the Party No. 1 shall pay the Party No. 3 in cash or cheque the amount of One Million One Hundred Five Thousand (P 1,105,000.00) Pesos representing expenses incurred in the refurbishing/conversion of the seventeen (17) units Commando at P 65,000.00 each;
2. Party No. 2 shall entrust to the Party No. 3 the aforementioned Armalite rifles for refurbishing/conversion. In case of missing or totally beyond repair spare parts, Party No. 2 shall undertake to replace them with serviceable parts on one to one basis. Said unserviceable parts shall be returned to the PNP;
3. Ammunition to torture test of fifty (50) bullets per unit shall be provided by the Party No. 2, such test shall be supervised by the personnel of the Directorates for Research and Logistics, PNP who shall pass upon the worthiness of the modified units;
4. Party No. 3 shall complete the refurbishing/conversion according to the aforementioned specifications within \_\_\_\_\_ (\_\_\_\_) working days from the signing of this MOA;
5. Once the aforementioned units are finally turned over for custody and possession of the City Police Station, said units (M16 rifles) will remain issued to the latter and shall not be recalled unless it becomes Beyond Economical Repair (BER);
6. This Agreement shall be effective upon signing by the PARTIES and shall be automatically terminated upon the acceptance of the refurbished/converted Armalite rifles by the PARTIES involved in an appropriate ceremony.
