**RESOLUTION NO. 512, s-2008**

**“A RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 02, SERIES OF 2008 OF THE SANGGUNIANG BARANGAY OF MANKILAM, TAGUM CITY OPERATIVE EFFECTIVE UPON ITS APPROVAL.”**

**WHEREAS**, forwarded to this august body is Supplemental Budget No. 02 of Barangay Mankilam, Tagum City as authorized by the Sangguniang Barangay under Appropriation Ordinance No. 02, series of 2008, appropriating the sum of One Million Six Hundred Forty Four Thousand Five Hundred Forty Five Pesos & 13/100 (P 1,644,545.13) only, for appropriate action;

**WHEREAS**, per evaluation pursuant to Section 333 of the Local Government Code of 1991 otherwise known as Republic Act No. 7160, it was found to have substantially complied with the provision of law;

**WHEREAS**, this august body deems it proper to declare operative said appropriation ordinance, subject however to the following conditions:

1. That all applicable accounting and auditing rules and regulations in the disbursement of funds released by the barangay shall be strictly observed.
2. That the responsibility for the execution of this supplemental budget and the accountability therefore shall be vested primarily to the Local Chief Executive.

**NOW THEREFORE**, be it resolved by the 4<sup>th</sup> City Council of Tagum City to declare Appropriation Ordinance No. 02, series of 2008 of the Sangguniang Barangay of Mankilam, Tagum City operative effective upon its approval, subject however to the conditions stated above.

**RESOLVED FURTHER**, that copies of this resolution be furnished to the Sangguniang Barangay of Mankilam, Tagum City and to all offices concerned for their information and record.
