RESOLUTION NO. 536, S-2008

A RESOLUTION DEMANDING THAT THE NORTH DAVAO COLLEGE-TAGUM FOUNDATION, INCORPORATED REFUND THE REVIEW FEE OF P10,000.00 PAID BY ITS NURSING GRADUATES WHO DID NOT AVAIL OF THE SCHOOL'S REVIEW PROGRAM AND THE MOCK BOARD FEE OF P7,500.00 CHARGED ON EACH SUCCEEDING MOCK EXAMINATION.

WHEREAS, North Davao College-Tagum Foundation, Incorporated has recently figured in a controversy with its nursing program wherein questionable practices were brought into the open by several of its nursing graduates;

WHEREAS, one of the issues raised was the automatic collection of a review fee amounting to P10,000.00 which is tantamount to compulsory enrolment to the review class of the school's choice;

WHEREAS, another issue brought into the open was the collection of a mock board fee amounting to P7,500.00 for those who fail in the first mock board examination and decide to retake, even if they have already paid the amount during their first take;

WHEREAS, as pronounced by key officials from the Commission on Higher Education, such practice is not allowed by the commission, hence illegal;

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum to demand that the North Davao College-Tagum Foundation, Incorporated refund the review fee of P10,000.00 paid by its nursing graduates who did not avail of the school's review program and the mock board fee of P7,500.00 charged on each succeeding mock board examination.

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned agencies and offices.
