RESOLUTION NO. 538, S-2008

A RESOLUTION RECOMMENDING TO THE COMMISSION ON HIGHER EDUCATION THE NON-RENEWAL OF NORTH DAVAO COLLEGE – TAGUM FOUNDATION, INCORPORATED'S PERMIT TO OPERATE A NURSING SCHOOL

WHEREAS, several complaints have been brought into the open by Nursing graduates of North Davao College-Tagum Foundation, Incorporated regarding the school's refusal to release their school credentials necessary for the filing of application for National Licensure Examination for Nurses;

WHEREAS, the Sanggunian has for the past weeks exhausted all means to resolve the issue, even to the extent of seeking the intervention of the Commission on Higher Education Regional Office but the efforts have so far produced uncertain results as the said school simply refused to cooperate and do their share in addressing the problem;

WHEREAS, such display of indifference to the plight of their graduates as well as to the efforts of the sanggunian and the CHED to act on the matter prompted this august body to draft a resolution declaring some key people from the North Davao College-Tagum Foundation, Incorporated as Personae Non Gratae;

WHEREAS, along with the belief of the members of this august body that the North Davao College-Tagum Foundation, Incorporated has been showing highest degree of unprofessionalism is the view that the institution is unfit to operate a nursing school;

NOW THEREFORE, BE IT RESOLVED by the Sangguniang Panlungsod of Tagum to recommend to the Commission on Higher Education the non-renewal of North Davao College-Tagum Foundation Incorporated's permit to operate a nursing school.

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned offices and agencies.
