WHEREAS, in the past, the City Government of Tagum through the City Mayor entered into a contract of affiliation with North Davao College with regard to the school's nursing program;

WHEREAS, recent events have led this august body to the realization that the thrust of the school is after all not in line with what the city government of Tagum has been espousing all these years;

WHEREAS, welcoming the idea of any future undertakings with the NDC-TFI would contradict with the most recent move of this council to declare some key officials of the school as personae non gratae;

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum to manifest the stand of the City Government of Tagum to never again enter into any contract of affiliation with the North Davao College-Tagum Foundation, Incorporated.
