RESOLUTION NO. 540, S-2008

A RESOLUTION URGING THE CITY MAYOR, HON. REY T. UY FOR THE REVOCATION OF NORTH DAVAO COLLEGE-TAGUM FOUNDATION, INCORPORATED'S PERMIT TO OPERATE ITS NURSING PROGRAM IN THE CITY OF TAGUM

WHEREAS, several complaints from nursing graduates of North Davao College-Tagum Foundation, Incorporated regarding some acts of their school officials which constitute anti-student and anti-poor inclinations have reached the halls of the sanggunian;

WHEREAS, the Sangguniang Panlungsod of Tagum, acting on such complaints, did its best to settle the matter as an intermediary to the point of inviting for a conference the parties involved, including representatives from the Commission on Higher Education;

WHEREAS, such efforts of the sanggunian produced slow-paced progress due to the unwillingness of the NDC-TFI officials to cooperate;

WHEREAS, these events have led this august body to the realization that the acts being shown by the officials of the school reveal a thrust that is contrary to what has been espoused by the city government of Tagum;

WHEREAS, the City of Tagum does not need in its midst the existence of schools that are espousing oppressive practices;

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum to urge the City Mayor, Hon. Rey T. Uy for the revocation of North Davao College-Tagum Foundation, Incorporated's permit to operate its Nursing Program in the City of Tagum.

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned offices and agencies.
