**RESOLUTION NO. 559, 2008**

**A RESOLUTION EXTENDING FUNERAL AND BURIAL ASSISTANCE IN FAVOR OF THE FAMILY OF THE LATE ISRAEL M. MAUG, FORMER PUNONG BARANGAY OF BARANGAY BINCUNGAN, TO COVER FOR THE EXPENSES OF THE LATTER IN THE AMOUNT OF TWENTY THOUSAND (P20,000.00) PESOS.**

**WHEREAS**, it is the policy of the City Government of Tagum to ensure that the welfare of its constituents are always upheld;

**WHEREAS**, it is also the policy of the City Government of Tgum to provide the Public Servants not only moral but also financial and burial assistance during unavoidable events such as sickness, injury, accident and death;

**WHEREAS, ISRAEL M. MAUG**, served as Punong Barangay of Barangay Bincungan since 1997;

**WHEREAS, ISRAEL M. MAUG**, volunteered to be the guide in identifying the suspects of a drug syndicated group using his private vehicle while conducting surveillance against the alleged drug pushers/dealers;

**WHEREAS, ISRAEL M. MAUG**, suffered gun shots from the encounter against the drug syndicated group at Purok D-1, Sitio Carmen, Barangay Madaum;

**WHEREAS**, the said encounter caused the death of **ISRAEL M. MAUG**, on November 28, 2008 at 2:00 o'clock in the afternoon at Barangay Madaum;

**WHEREAS**, the City Government of Tagum resolves to provide funeral and burial assistance to the immediate family of the late **ISRAEL M. MAUG**, in the amount of TWENTY THOUSAND PESOS (P20,000.00), to help them in their expenses and some way alleviate their grief;

**WHEREAS**, the source of funds shall be taken from the Awards and Indemnities;

**NOW THEREFORE**, be it resolved by the Sangguniang Panlungsod of Tagum, to extend funeral and burial assistance in favor of the family of the late **ISRAEL M. MAUG**, Punong Barangay of Barangay Bincungan, to cover for the expenses of the latter in the amount of Twenty Thousand (P20,000.00) Pesos;

**RESOLVED FURTHER**, that copies of this resolution shall be furnished to the family of the late **ISRAEL M. MAUG**, and to all offices concerned for their information and guidance.
