**RESOLUTION NO. 562, S-2008**

**A RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO CONRADO B. PALEN, ASSIGNED AT THE CIVIL SECURITY UNIT, TO COVER FOR THE MEDICAL EXPENSES OF THE LATTER IN THE AMOUNT OF TEN THOUSAND PESOS (P10,000.00).**

**WHEREAS**, it is among the policies of the present administration to extend financial assistance to those in need of immediate medical attention but lack the financial capacity to avail of the same;

**WHEREAS**, CONRADO B. PALEN is employed in the City Government of Tagum as Intel Operative of the PNP;

**WHEREAS**, CONRADO B. PALEN suffered gun shots while on duty on November 28, 2008 at about 2:00 o'clock in the afternoon at Barangay Madaum;

**WHEREAS**, the said accident caused CONRADO B. PALEN's confinement at the Davao Regional Hospital for treatment of gun shot wounds;

**WHEREAS**, due to the above-mentioned hospitalization, Conrado B. Palen is in need of immediate medical attention that requires various medicines that are very costly;

**WHEREAS**, if the medicines will not be administered shortly, complications will set in;

**WHEREAS**, the City Government of Tagum, in recognizing the urgency of the situation, is extending financial assistance to Conrado B. Palen to cover his medical expenses in the amount of TEN THOUSAND (P 10,000.00) PESOS;

**WHEREAS**, the source of funds shall be taken from the Awards and Indemnities;

**NOW THEREFORE**, be it resolved by the Sangguniang Panlungsod of Tagum, to extend financial assistance to Conrado B. Palen, assigned at the Civil Security Unit, to cover for the medical expenses of the latter in the amount of Ten Thousand Pesos (P10,000.00);

**RESOLVED FURTHER**, that copies of this resolution shall be furnished to CONRADO B. PALEN, and to all offices concerned for their information and guidance.
