RESOLUTION NO. 587, S-2008

A RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 04, SERIES OF 2008 OF THE SANGGUNIANG BARANGAY OF MAGUGPO POBLACION, TAGUM CITY, OPERATIVE EFFECTIVE UPON ITS APPROVAL.

WHEREAS, Appropriation Ordinance No. 04, series of 2008 of the Sangguniang Barangay of Magugpo Poblacion, Tagum City appropriating the amount of Four Million Four Hundred Six Thousand Nine Hundred Sixty Nine Pesos & 19/100 (P 3,887,664.00) only, was presented to this august body for appropriate action;

WHEREAS, per final evaluation pursuant to Section 333 of the New Local Government Code it was found to have substantially complied with the provisions of law;

WHEREAS, based on final review, it is recommended to declare operative Appropriation Ordinance No. 04, series of 2008 of Barangay Magugpo Poblacion, subject however to the following conditions:

1. That all applicable accounting and auditing rules and regulations in the disbursement of funds released by the barangay shall be strictly observed.
2. That the responsibility for the execution of this Annual Budget and the accountability therefore shall be vested primarily to the Local Chief Executive.

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum to declare Appropriation Ordinance No. 04, series of 2008 of the Sangguniang Barangay of Magugpo Poblacion, Tagum City operative effective upon its approval, subject however to the conditions stated above;

RESOLVED FURTHER, that copy of this resolution shall be furnished to the Sangguniang Barangay of Magugpo Poblacion, Tagum City and to all offices concerned for their information and record.
