RESOLUTION NO. 650, S-2009

A RESOLUTION REQUESTING HER EXCELLENCY PRESIDENT GLORIA MACAPAGAL-ARROYO ONE (1) UNIT PCSO AMBULANCE TO BE USED FOR EMERGENCY INCIDENTS IN THE CITY OF TAGUM.

WHEREAS, RA 7160, otherwise known as the Local Government Code (LGC) of 1991 contain provisions of goals and objectives of disaster preparedness, prevention/mitigation programs that reinforce the pursuit of Disaster Management Program at the local government level;

WHEREAS, Presidential Decree No. 1566 which was promulgated on June 11, 1978, calls for the "Strengthening of the Philippine Disaster Control Capability establishing the National Program on Community Disaster Preparedness";

WHEREAS, the Tagum City Disaster Coordinating Council (CDCC) has only one (1) ambulance that caters all twenty-three (23) barangays with a population of more than 215,967;

WHEREAS, the city finds it difficult to fulfill its obligation and meet all the emergency situations due to limited resources;

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum to request Her Excellency President Gloria Macapagal-Arroyo one (1) unit PCSO ambulance to be used for emergency incidents in the City of Tagum.
