RESOLUTION NO. 699, S-2009

A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. REY T. UY TO TRANSACT FOR AND IN BEHALF OF THE CITY GOVERNMENT OF TAGUM IN THE ACQUISITION OF TWO (2) UNITS PCSO AMBULANCE TO BE PROCURED THRU THE LEAGUE OF CITIES OF THE PHILIPPINES (LCP) ON A COST-SHARING SCHEME.

WHEREAS, it is the policy of the City Government of Tagum to ensure that the welfare of its constituents are always upheld;

WHEREAS, to better serve the constituents, LGU Tagum is in need of additional equipment of which the ambulance is included;

WHEREAS, the LGU Tagum earnestly requests Mayor Benjamin C. Abalos, Jr., LCP President, for approval of the procurement of two (2) units PCSO ambulances including its medical equipment on a cost-sharing scheme;

WHEREAS, the City Government of Tagum finds it favorable to accept the procurement scheme on a 60% - 40% cost sharing of which PCSO will shoulder the 60% of its acquisition cost while the remaining 40% as the LGU's counterpart;

WHEREAS, the Sanggunian Panlungsod Members are in full support of the cost-sharing scheme in the procurement of the two (2) units Ambulance;

WHEREAS, an amount of Eight Hundred Thousand (P 800,000.00) Pesos under Capital Outlay – Ambulance was approved in Supplemental Budget (SB) No. 1, s-2009 for the acquisition of the two (2) units Ambulance;

WHEREAS, the two (2) units of PCSO Ambulance will be of great help to the City Government of Tagum especially during emergencies and aftermath of man-made and natural disasters;

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum to authorize the City Mayor, Hon. Rey T. Uy, to transact for and in behalf of the City Government of Tagum in the acquisition of two (2) units PCSO Ambulance to be procured thru the League of Cities of the Philippines (LCP) on a cost-sharing scheme.

RESOLVED FURTHER, that copies of this resolution be furnished to all offices concerned for their information and guidance.
