RESOLUTION NO. 710, s-2009

A RESOLUTION REQUESTING HER EXCELLENCY, GLORIA MACAPAGAL ARROYO, PRESIDENT, REPUBLIC OF THE PHILIPPINES TO ISSUE AN AMENDMENT OF PROCLAMATION NO. 695 STIPULATING THERETO THAT THE LGU OF TAGUM BE GRANTED OWNERSHIP OF THE SAID PARCELS OF LAND COVERED IN THE SAID PROCLAMATION, FOR PURPOSES OF THE “TAGUM CITY HALL” AND THE “OLD MARKET AND TRADE CENTER” SITES.

WHEREAS, a letter from the Regional Executive Director, Ricardo L. Calderon, dated May 27, 2008 requires the LGU to submit a resolution for the amendment of Proclamation No. 695, more particularly, in order to effect the request of the City Government of Tagum, the issuance of Special Patent;

WHEREAS, Proclamation No. 695 covering Lot No. 2, Lot No. 3 and Lot No. 4 Swo-11-000001-D merely reserved the parcels of land for use of the LGU of Tagum;

WHEREAS, what was granted to the LGU of Tagum through the said proclamation was only administration of the land. Thus, in order to pursue the Presidential Proclamation and consequently, the issuance of Special Patent, the City Government of Tagum must therefore, submit the required resolution requesting to amend the said proclamation;

WHEREAS, the purpose of the amendment of Proclamation No. 695 is to change what has been stipulated in the said proclamation into a provision specifying that ownership is being granted to the City Government of Tagum over its covered lots;

WHEREAS, this effort is in line with the titling program of the City Government of Tagum in all of its real properties by establishing legal documents to claim absolute ownership over said parcels of land.

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum to request Her Excellency, Gloria Macapagal Arroyo, President, Republic of the Philippines, to issue an amendment of Proclamation No. 695 stipulating thereto that the LGU of Tagum be granted ownership of the said parcels of land covered in said proclamation for purposes of the "Tagum City Hall" and the "Old Market and Trade Center" sites.
