**RESOLUTION NO. 718, S-2009**

**A RESOLUTION GRANTING DEVELOPMENT PERMIT UNDER BP 220 TO MALINAWON URBAN POOR HOMEOWNERS ASSOCIATION, INC. AS REPRESENTED HEREIN BY MR. BONIFACIO C. LU-AY FOR A SUBDIVISION WITHOUT HOUSING COMPONENTS, CONTAINING AN AREA OF 8,743 SQUARE METERS, LOCATED AT PUROK MALINAWON, BARANGAY MAGUGO EAST, TAGUM CITY.**

**WHEREAS**, the Office of the City Mayor has endorsed the application of Mr. Bonifacio C. Lu-ay, President of the Malinawon Urban Poor Homeowners Association, Inc. for approval of a subdivision development plan which includes documents required in the process of development permit on February 23, 2009 to this august body;

**WHEREAS**, the submitted plan satisfactorily complied with the minimum requirements set in Sec. 10, Rule III of the Revised Implementing Rules and Standards for Economic and Socialized Housing as manifested in the Local Zoning Board Site Inspection and Evaluation Report dated January 9, 2009;

**WHEREAS**, Paragraphs 2 (x), section 458 of Republic Act 7160, otherwise known as the Local Government Code of 1991 empowers the Sangguniang Panlungsod subject to the national law, to process and approve subdivision plans for residential, commercial or industrial purposes;

**WHEREAS**, it is incumbent upon this august body to grant the Development Permit of the said applicant;

**NOW THEREFORE**, be it resolved by the Sangguniang Panlungsod of Tagum to grant Development Permit under BP 220 to Malinawon Urban Poor Homeowners Associat, Inc. as represented herein by Mr. Bonifacio C. Lu-ay for a subdivision without housing components, containing an area of 8,743 square meters, located at Purok Malinawon, Barangay Magugpo East, Tagum City.
