RESOLUTION NO. 728, s-2009

A RESOLUTION REQUESTING THE LAND TRANSPORTATION FRANCHISING AND REGULATORY BOARD (LTFRB) FOR THE CONTINUED RENEWAL OF FRANCHISE REGISTRATION OF FILCAB AS LONG AS THEY REMAIN ROAD WORTHY VEHICLE FOR PUBLIC UTILITY SERVICES.

WHEREAS, the provision for the welfare of the local residents is within the inherent power of the state as embodied under Section 16 of the Local government Code;

WHEREAS, Section 17 of RA 7160 provides that the Local government Unit shall endeavor to be self-reliant and shall exercise powers and discharge such other functions and responsibilities as necessary, appropriate or incidental to efficient and effective provision of the basic services and facilities;

WHEREAS, the existing policy of LTFRB limiting the renewal of registration of FILCAB units as a public conveyance to ten (10) years only is economically unsound on the part of FILCAB operators, per Department Order No. 2002-30;

WHEREAS, Madaum Tagum PUJ Operators and Drivers Association, Inc. (MATPODA) derive their main source of livelihood from their Filcab units;

WHEREAS, MATPODA members undertake to maintain the roadworthiness of their respective Filcab units;

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum City to request the Land Transportation Franchising and Regulatory Board (LTFRB) for the continued renewal of franchise registration of Filcab as long as they remain road worthy vehicle for public utility services.

RESOLVED FURTHER, that copies of this resolution be furnished to the LTFRB Regional Office and other offices concerned.
