**RESOLUTION NO. 734, s-2009**

**A RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 03, SERIES OF 2008 OF THE SANGGUNIANG BARANGAY OF MAGUGPO NORTH, TAGUM CITY, OPERATIVE EFFECTIVE UPON ITS APPROVAL.**

**WHEREAS**, Appropriation Ordinance No. 03, s-2008 of the Sangguniang Barangay of Magugpo North, Tagum City, appropriating the amount of Two Million One Hundred Eleven Thousand (P 2,111,000.00) Pesos only, was presented to this august body for appropriate action;

**WHEREAS**, per evaluation pursuant to Section 333 of the Local Government Code of 1991 otherwise known as Republic Act No. 7160, it was found to have substantially complied with the provision of law;

**WHEREAS**, based on final review, it is recommended to declare operative Appropriation Ordinance No. 03, s-2008 of Barangay Magugpo North, subject however to the following conditions;

1. That all applicable accounting and auditing rules and regulations in the disbursement of funds released by the barangay shall be strictly observed;
2. That the responsibility for the execution of this Annual Budget and the accountability therefore shall be vested primarily to the Local Chief Executive.

**NOW THEREFORE**, be it resolved by the Sangguniang Panlungsod of Tagum to declare Appropriation Ordinance No. 03, series of 2008 of the Sangguniang Barangay of Magugpo North, Tagum City operative effective upon its approval, subject however to the conditions stated above.

**RESOLVED FURTHER**, that copies of this resolution be furnished to the Sangguniang Barangay of Magugpo North, Tagum City and to all offices concerned for their information and guidance.
