**RESOLUTION NO. 748, s-2009**

**A RESOLUTION REQUESTING THE AVIAN INFLUENZA TASK FORCE (AITF), AIP, XFM, UMBN-DXDN, STV NETWORK, PERIODICO, CORRIDOR AND TANLAG TO ACT AS THE TASK FORCE FOR THE "H1N1 INFLUENZA A VIRUS" PANDEMIC TO EXPEDITE MONITORING, CONTAINMENT AND DISSEMINATION OF CORRECT INFORMATION TO THE CONSTITUENTS OF TAGUM CITY.**

**WHEREAS**, the AITF is an organized task force that is capable of speeding up information drive to the constituents of Tagum on matters regarding virus and health issues since the said group have already had the skills and experience on the prevention and containment of the avian influenza incident, which is somehow similar to the present pandemic;

**WHEREAS**, information dissemination should come from the proper authorities e.g. City Health Office, AITF and its media partners through the program (X'FM) "Tagum Padayon sa Pag-uswag" and "Radyo Rapido" (anchored by Mr. Marlon Velez), (UMBN-DXDN) Radyo Ukay morning edition", "Maayong Buntag Tagum" (anchored by Mr. Ruel Dagsangan/Aurora A. Lozada), STV Network, FM Sug-angan sa Kabuntagon (anchored by Mr. Rey Nagar) and newspapers Corridor and Tanlag;

**WHEREAS**, the spread of the said "H1N1 Influenza A Virus" is gradually increasing in other countries and there is significant threat that it may possibly break in (Philippines) Tagum;

**WHEREAS**, since there are misconceptions on the phenomenon, especially as regards eating pork, thus, it is imperative that information dissemination will be massive and with urgency so that the swine industry will not suffer;

**RESOLUTION NO. 748, s-2009**, cont'd:

**NOW THEREFORE**, be it resolved by the Sangguniang Panlungsod of Tagum City to request the Avian Influenza Task Force (AITF), AIP, XFM, UMBN-DXDN, STV Network, Periodico, Corridor and Tanlag to act as the Task Force for the "H1N1 Influenza A Virus" pandemic to expedite monitoring, containment and dissemination of correct information to the constituents of Tagum City.
