**RESOLUTION NO. 767, s-2009**

**A RESOLUTION APPROVING THE APPLICATION FOR REVALIDATION OF PRELIMINARY APPROVAL AND LOCATIONAL CLEARANCE (PALC) OF COCOPLANS, INC. AS REPRESENTED HEREIN BY MR. ROLANDO N. LIGAS FOR THE ESTABLISHMENT OF PALM HAVEN MEMORIAL PARK PROJECT CONTAINING AN AREA OF 48,831 SQUARE METERS LOCATED AT BARANGAY BINCUNGAN, TAGUM CITY.**

**WHEREAS**, the application for the revalidation of Preliminary Approval and Locational Clearance ( PALC ) for the establishment of Palm Haven Memorial Park Project in Barangay Bincungan , Tagum City was presented for consideration and appropriate action;

**WHEREAS**, Rules and Regulations for Memorial Parks and Cemeteries direct all developers the filing of applications for Preliminary Approval and Locational Clearance (PALC) before converting the subject parcel of land into a memorial park to the Local Government Unit concerned which shall be valid for a period of one hundred eighty (180) days only from date of approval, otherwise revalidation shall be applied;

**WHEREAS**, the committee found out that Cocoplans, Inc. has been granted Preliminary Approval and Locational Clearance by the Sangguniang Panlungsod of Tagum on June 12, 2007 though Resolution No. 632, which date is already beyond the period specified in the rules within which to submit and process application for final approval /development permit;

**WHEREAS**, Paragraph 2 (x) Section 458 of Republic Act 7160, otherwise known as the Local Government Code of 1991 empowers the Sangguniang Panlungsod subject to the national law, to process and approve subdivision plans for residential, commercial or industrial purposes;

**WHEREAS**, it is incumbent upon this august body to approve the application for Preliminary Approval and Locational Clearance (PALC) of the said applicant;

**NOW THEREFORE**, be it resolved by the Sangguniang Panlungsod of Tagum to approve the application for revalidation of Preliminary Approval and Locational Clearance (PALC) of Cocoplans, Inc. as represented herein by Mr. Rolando N. Ligas for the establishment of Palm Haven Memorial Park Project containing an area of 48,831 square meters, located at Barangay Bincungan, Tagum City,

**RESOLVED FURTHER**, that copies of this resolution be furnished to Mr. Rolando N. Ligas, City Planning and Development Office, City Engineering Office and other offices concerned for their information.
