RESOLUTION NO. 778, s-2009

A RESOLUTION AUTHORIZING THE CITY MAYOR OF TAGUM, HON. REY T. UY TO ENTER INTO AND SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF TAGUM THE RADIO CONTRACT WITH THE SWARA SUG MEDIA CORPORATION FOR THE INFORMATION PLUG SPONSORSHIP, "PHONE PATCH" INTERVIEW IN BARUGANAN OR EL KAPITAN PROGRAM, AOB ANNOUNCE ON BOARD IN EL KAPITAN PROGRAM OF DXRD 711 SONSHINE RADIO.

WHEREAS, radio broadcast is one of the fastest mediums of mass communication to the constituents of the city;

WHEREAS, having a radio program it is the best way to inform the constituents ON AIR of what has been going on especially our local government's latest programs, projects, services and achievements, and to discuss relevant issues concerning public service and promote the city within its community or in the whole region of Davao;

WHEREAS, there will be an advisory plugging and AOB's of "PR's" through DXRD 711 Sonshine Radio "EL KAPITAN PROGRAM" by way of a phone patch interview concerning the accurate dissemination of relevant information of city's achievements and developments and other information dissemination of various projects of the City Government of Tagum;

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum to authorize the City Mayor of Tagum, Hon. Rey T. Uy to enter into and sign for and in behalf of the City Government of Tagum the radio contract with the Swara Sug Media Corporation for the information plug sponsorship, "Phone Patch" interview in Baruganan or El Kapitan Program, AOB announce on board in El Kapitan Program of DXRD 711 Sonshine Radio.

RESOLVED FURTHER, that the full text of the Contract of Service shall be as follows:

CONTRACT OF SERVICE

KNOW ALL MEN BY THESE PRESENTS:

The CONTRACT is made and executed by and between:

The CITY OF TAGUM, herein represented by the Honorable Mayor REY T. UY, duly authorized by the Sangguniang Panlungsod through Res. No. _____, s-2009, hereinafter called as PARTY OF THE FIRST PART;

-and-

The SWARA SUG MEDIA CORPORATION, herein represented by its OIC Station Manager, Mirasol Reyes, hereinafter called as the PARTY OF THE SECOND PART;

WHEREAS, the PARTY OF THE FIRST PART is desirous to provide the constituents of the city a tool and a venue to interact and benefit from the city government plans and livelihood projects. The said info plug or radio program of the PARTY OF THE SECOND PART will also serve to enable the public to participate in the formulation and encourage listeners to give their views and opinions pertaining issues that affect the general public.

WHEREAS, the PARTY OF THE SECOND PART, TV/Radio Broadcast Corporation operating in the key cities of the Philippines and other parts of the world as well, will air the program with the same purpose in view;

WHEREAS, in view of the premises, it is hereby agreed:

1. That the PARTY OF THE FIRST PART shall have (2) 30's/60's advisory plug or "Info Plug" by the city Mayor's project and achievements daily (Monday to Saturday). And the production cost for DXRD Sonshine Radio Advisory is FREE.
2. That the PARTY OF THE SECOND PART shall air 5-10 min. "phone patch" interview during Baruganan or El Kapitan Program anchored by Nerio Guimte (once a week) to discuss relevant issues concerning public service and promote the city within its community or in the whole region of Davao. And shall air (2) time-chicks daily from Monday to Friday.
3. That the PARTY OF THE FIRST PART shall have a bonus of (2) AOB's for Press Release/s of any major activities of Tagum City during "El Kapitan" program daily (8:30 – 9:30 a.m.) Monday to Friday.
4. That for and in consideration of the service, the PARTY OF THE SECOND PART shall receive a package in the amount of Seven Thousand Five Hundred (P7,500.00) Pesos monthly (VAT Exclusive).
5. That this contract shall have a term of one year (1) from May 2009 - December 2009 and can be renewed at the option of the PARTY OF THE FIRST PART. Further that this contract maybe terminated by the PARTY OF THE FIRST PART even without or against the consent of the PARTY OF THE SECOND PART when the exigencies of public service so requires it.
