**RESOLUTION NO. 801, s-2009**

**A RESOLUTION AUTHORIZING THE CITY MAYOR OF TAGUM, HON. REY T. UY, TO ENTER INTO AND SIGN A CONTRACT FOR AND IN BEHALF OF THE CITY GOVERNMENT OF TAGUM WITH RADIO STATION MABUHAY K95 FM BROADCASTING SERVICE REPRESENTED BY ITS STATION MANAGER SAMUEL F. LUZON IN CONNECTION WITH THE RADIO PROGRAM FROM JULY 2009 TO SEPTEMBER 2009.**

**WHEREAS**, it is the right of every citizen in the City of Tagum to be informed of the developments and projects of the city government;

**WHEREAS**, "TAGUM PADAYONSA PAG-USWAG" program is the outcome of the great desire of the City Government of Tagum to disseminate information and to update the public regarding the plans, projects, livelihood and development programs of this city;

**WHEREAS**, radio broadcast is the speediest medium of communicating to the people in the city and nearby vicinities, through it, the people can also easily react and be updated about the programs of the city;

**NOW THEREFORE**, be it resolved by the Sangguniang Panlungsod of Tagum to authorize the City Mayor of Tagum, Hon. Rey T. Uy to enter into and sign a contract for and in behalf of the City Government of Tagum with Radio Station Mabuhay K95fm Broadcasting Service represented by its Station Manager, Samuel F. Luzon in connection with the radio program from July 2009 to September 2009.

**RESOLVED FURTHER**, that the text of the contract of service shall read as follows:

**CONTRACT OF SERVICE**

**KNOW ALL MEN BY THESE PRESENTS:**

The **CONTRACT** is made and executed by and between:

The **CITY OF TAGUM**, herein represented by the **Honorable Mayor Rey T. Uy**, duly authorized by the Sangguniang Panlungsod Resolution No. \_\_\_\_, s-2009, herein after called as the **PARTY OF THE FIRST PART;**

-and-

The **MABUHAY K95 FM BROADCASTING CORPORATION SERVICE**, represented by its Station Manager, **SAMUEL F. LUZON**, hereinafter called as the **PARTY OF THE SECOND PART;**

-over-

**WITNESSETH:**

**WHEREAS**, the **PARTY OF THE FIRST PART** is desirous to give information to the constituents of the city to interact and benefit from the city government plans and livelihood projects through the proper dissemination of relevant information to the public.

The said program, "TAGUM PADAYONSA PAG-USWAG" will also serve to enable the public to participate in the formulation of plans through the city officials who will be invited to explain their roles and policies by way of focusing these assistance to the people.

**WHEREAS**, the **PARTY OF THE SECOND PART** will air the said program with same purpose in view;

**WHEREAS**, the people of Tagum of the above premises, the herein portion have agreed:

1. That the **PARTY OF THE FIRST PART** with anchorman and guests of the herein program to be aired over K95 FM from 8:00 – 9:00 a.m.; Monday to Friday.
2. That for and in consideration of the said service, the **PARTY OF THE SECOND PART** shall receive a payment in the amount of **TWENTY FOUR THOUSAND (P 24,000.00)** per month.
3. That the **PARTY OF THE SECOND PART** shall render assistance in the production designs (this include plugging of the LGU's Program 6 times daily, assist in the preparation of the voice over of the city's various program in the form of broadcast ads) and assign technical personnel during the anchorman-guests-callers interaction.
4. That the format of the program shall require the anchorman, together with guests coming from the public or private sector, to disseminate or discuss information or issues that will exclusively promote the economic social and moral well-being of the people of the City of Tagum.
5. That the **PARTY OF THE SECOND PART** shall assure that there will be no other programs or block timers who shall speak in contrast against the **PARTY OF THE FIRST PART** since its radio program itself already cater reactions and suggestions.

That this contract shall have a term from July 2009 to September 2009, and is renewable at the option of the **PARTY OF THE FIRST PART**. Further, that this contract maybe terminated by the **PARTY OF THE FIRST PART** even without or against the consent of the **PARTY OF THE SECOND PART** when the exigencies of public service so requires.
