RESOLUTION NO. 803, s- 2009

“A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE REY T. UY, CITY MAYOR TO ENTER, NEGOTIATE AND SIGN CONTRACT, AGREEMENT OR INSTRUMENTS RELATIVE TO THE PROJECTS/ PROGRAMS SOLELY FUNDED BY THE NATIONAL GOVERNMENT”.

WHEREAS, Section 25 paragraph (b) and (c) of Republic Act 7160, Otherwise known as Local Government Code of 1991, expressly provides that, “Consistent with the basic policies on local autonomy, the President shall exercise general supervision over local government units to ensure that their acts are within the scope of their power and functions;

- b. National Agencies and offices with project implementation function shall coordinates with one another and with the local governments units concerned in the discharge of these functions. They shall ensure the participation of local government units both in the planning and implementation of said national projects.
- c. The President may, upon request of the local government unit concerned, direct the appropriate national agency to provide financial technical or other forms of assistance to the local government unit. Such assistance shall be extended at no extra cost to the local government unit concern.

WHEREAS, it is the concern of the implementing office/agencies as well as the members of the Sangguniang Panlungsod of Tagum that projects/programs sole funded by the national government should be implemented with out further delays;

WHEREAS, since projects/programs are considered priority projects of the government, which the approval of the corresponding Memorandum of Agreement and contracts thereof may be done frequently within the year round, thus, there is a need for an authority of the City Mayor to represent and sign all agreements/contracts under projects/programs en masse or in one time basis within a certain period from May 2009 to December 31, 2009 to avoid repetition of the same nature of agreement/contract solely funded by the National Government;

WHEREAS, every time a Memorandum of Agreement for a particular special projects has been entered and signed by the Honorable Mayor, the Office of the City Mayor shall furnish a copy of the said Memorandum of Agreement (MOA) of the Legislative Department through the Office of the City Vice Mayor prior to the implementation thereof for information and reference;

WHEREAS, after thorough discussion and deliberation during the plenary session, the august body agreed to authorize the Honorable Mayor to enter, negotiate and sign contract, agreement or instruments to the projects/programs solely funded by the national government;

NOW THEREFORE, BE IT RESOLVED, by the Sangguniang Panlungsod of Tagum to grant authority to the Honorable Rey T. Uy, City Mayor to enter, negotiate and sign contract, agreement or instruments relative to projects/programs solely funded by the national government.

RESOLVED FURTHER, that copies of this resolution be furnished to Hon. Rey T. Uy, City Mayor, City Legal Officer, City Budget Officer, City Treasurer, City Accountant, City Planning and Development Coordinator and Commission on Audit, all of this city for information and guidance.
