RESOLUTION NO. 51, S-2010

“A RESOLUTION REQUESTING HON. GREGORY L. DOMINGO, THE NEW SECRETARY OF THE DEPARTMENT OF TRADE AND INDUSTRY (DTI) TO INTERVENE IN THE EXCESSIVE PRICE RATE OF THE EMISSION TESTING CENTERS IN TAGUM CITY.”

WHEREAS, the provision for the welfare of the local residents is within the inherent power of the state as embodied under Section 16 of the Local Government Code;

WHEREAS, Section 17 of Republic Act 7160 provides that the Local Government shall endeavor and shall exercise powers and discharge such other functions and responsibilities as necessary, appropriate or incidental to efficient and effective provisions of the basic services and facilities;

WHEREAS, the City Government had been exerting efforts through series of consultations to all emission testing centers and other stakeholders to reduce the price of the emission test but the price still pegged at **Four Hundred Fifty Pesos (P400.00)**;

WHEREAS, neighboring city like Davao City and neighboring town like Nabunturan, Comval Province emission test has lower prices ranging from One Hundred Fifty (P150) to Two Hundred Eighty Pesos (P280.00);

WHEREAS, there is seemingly price cartel of the emission testing in Tagum City;

WHEREAS, the same resolution was approved by this Sanggunian last March 22, 2010 and forwarded to same office of which the signatures of the petitioners (single motor drivers) are attached, was not acted upon by the previous administration;

NOW THEREFORE BE IT RESOLVED, by the Sangguniang Panlungsod of Tagum City to request Hon. Gregory L. Domingo, the new Secretary of the Department of Trade and Industry (DTI) to intervene in the excessive price rate of the emission testing centers in Tagum City;

RESOLVED FURTHER, that copies of this resolution shall be furnished to the Office of the new Secretary of the Department of Trade and Industry and to all offices concerned.
