RESOLUTION NO. 118, s- 2010

“A RESOLUTION URGING ALL BUSINESS ESTABLISHMENTS, NATIONAL AGENCIES, GOVERNMENT OFFICES, GOVERNMENT OWNED AND CONTROLLED CORPORATIONS (GOCC), GOVERNMENT FINANCIAL INSTITUTIONS (GFI) AND INFRASTRUCTURE AND UTILITIES GROUP (IUG) OPERATING WITHIN THE CITY OF TAGUM TO PERIODICALLY SUBMIT THEIR LISTS OF JOB VACANCIES TO THE TAGUM CITY PUBLIC EMPLOYMENT SERVICE OFFICE (PESO) FOR LABOR MARKET INFORMATION PURPOSES TO JOBSEEKERS, EMPLOYERS AND RESEARCHERS.

WHEREAS, the City Government of Tagum , thru the Tagum City Public Employment Service Office (PESO) is duty bound to bring basic service of providing job placement information to all its constituents;

WHEREAS, the basic services and facilities must be provided for by the Local Government Units to its constituents including job placement information systems as provided for in Section 17 (V) of Republic Act 7160 known as the Local Government code of 1991;

WHEREAS, jobseekers regularly visit the Tagum City Public Employment Service Office (PESO) to look for job vacancies within the City of Tagum and Region XI;

WHEREAS, Tagum City PESO is equipped and competent to perform its function particularly in the pre- screening, job-matching and employment coaching, also PESO can provide the employers qualified jobseekers who match the qualification of vacancies they needed;

WHEREAS, Republic Act No. 8759 known as the PESO Act of 1999 mandates PESO to encourage employers to submit to the PESO on a regular basis a list of job vacancies in their respective establishments in order to facilitate the exchange of labor market information services to job seekers and employers by providing employment services to job seeker, both for local and overseas employment and recruitment assistance to employers;

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum to urge all Business Establishments, National Agencies, Government Offices, Government Owned and Controlled Corporation (GOCC), Government Financial Institutions (GFI) and Infrastructure & Utilities Group (IUG) operating within the City of Tagum to periodically submit their lists of job vacancies to the Tagum City Public Employment Service Office (PESO) for labor market information purposes to jobseekers, employers and researchers.
