**RESOLUTION NO. 126, s-2010**

**“A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. REY T. UY, TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF TAGUM THE AMENDED MEMORANDUM OF AGREEMENT (MOA) WITH THE UNIVERSITY OF SOUTHEASTERN PHILIPPINES (USEP), APOKON CAMPUS, REPRESENTED BY MR. PERFECTO A. ALIBIN, PRESIDENT, FOR THE ESTABLISHMENT OF A SATELLITE FOREST NURSERY IN THE CITY OF TAGUM.”**

**WHEREAS**, it is the policy of the state to implement community-based forestry projects;

**WHEREAS**, the City Government of Tagum with its objective of producing two thousand (2000) species of forest trees is in need of a considerable space for the accommodation of its seedlings;

**WHEREAS**, the City Government of Tagum has existing plant nursery at the Energy Park but with limited space;

**WHEREAS**, the University of Southeastern Philippines, Apokon Campus, which is acknowledged to be an Agricultural institution has no existing standard nursery which is essential for the advancement of its students;

**WHEREAS**, in consideration of the essential need of the academy for the establishment of Satellite Forest Nursery and the need of the City Government of Tagum for the accommodation of growing two-thousand (2000) species of forest trees, this MOA is visualized;

**WHEREAS**, the University of Southeastern Philippines has agreed to provide three fourths (3/4) of a hectare for the establishment of the nursery, likewise, the City Government of Tagum is amenable in providing necessary requirements for the realization of the project;

**WHEREAS**, both parties agreed to co-manage the said project;

**NOW THEREFORE**, be it resolved by the Sangguniang Panlungsod of Tagum to authorize the City Mayor, Hon. Rey T. Uy, to sign for and in behalf of the City Government of Tagum the amended Memorandum of Agreement (MOA) with the University of Southeastern Philippines (USEP), Apokon Campus, represented by Mr. Perfecto A. Alibin, President, for the establishment of a Satellite Forest Nursery in the City of Tagum.

**RESOLVED FURTHER**, that upon the approval and effectivity of this measure, Resolution No. 82, series of 2010 be sent to the archives;

**RESOLVED FURTHERMORE**, that the full text of the Memorandum of Agreement shall be as follows:

### **MEMORANDUM OF AGREEMENT**

#### **KNOW ALL MEN BY THESE PRESENTS:**

The Memorandum of Agreement is made and entered into by and between:

The City Government of Tagum, a Local Government Unit with office address at Rizal Street, Tagum City, duly represented herein by the City Mayor, **HON. REY T. UY**, hereinafter referred to as the **FIRST PARTY**;

The University of Southeastern Philippines (USEP), with office address at Apokon, Tagum City, duly represented herein by its President, Dr. Perfecto A. Alibin, hereinafter referred to as the **SECOND PARTY**;

#### **WITNESSETH:**

**WHEREAS**, pursuant to Local Government Code of 1991, the City Government of Tagum, whether acting on their own or in partnership with other agency is already provided with legal basis to initiate and institutionalize their own resources;

**WHEREAS**, the parties are jointly and severally concerned of their roles and responsibilities to establish Satellite Forest Nursery to provide protection, conservation and sustainable forest resources;

**WHEREAS**, the parties recognize that by harnessing collaborative effort, projects can be established more efficiently and hereby declare to jointly establish as Satellite Forest Nursery using Superior Quality Stock Planting Materials for the reforestation, Community Watershed Project in all areas of Tagum City.

**NOW THEREFORE**, for and in consideration of the foregoing premises and by way of formalizing their commitments, the parties hereby agree as follows:

#### **A. The First Party shall:**

1. Prepare plans and programs for the establishment of forest nursery;
2. Provide budgetary requirements regarding cost estimates needed for nursery materials, tools, equipment, seeds, salary for the laborers and for research programs;
3. Construct Satellite Forest Nursery to provide massive production of the Superior Quality Planting Stock Materials using sexually and asexually propagated grown seedlings for the reforestation and community watershed project;
4. Provide free access to the students in the use of the Satellite Forest Nursery area for their subjects related to the abovementioned training facilities;
5. Be responsible for the management of the Satellite Forest Nursery;
6. Commence the construction and or implementation of the project within a period of two (2) years, otherwise this MOA will automatically be revoked.

**B. The Second Party shall:**

1. Provide land area approximately .75 hectares for the establishment of Satellite Forest Nursery;
2. Generate technology through funded research from the First Party for the proper handling and proper nursery propagation technique;
3. Formulate extension project proposal relative to the involvement of USEP Forestry Faculty;
4. Avail of the seedlings from the Satellite Forest Nursery for its tree planting activities;
5. Co-manage the Satellite Forest Nursery.

This MOA shall be effective for a period of five (5) years, subject to renewal at the option of the First Party/City Government of Tagum.
