**RESOLUTION NO. 136, s-2010**

**A RESOLUTION EXTENDING FINANCIAL AND BURIAL ASSISTANCE IN FAVOR OF THE FAMILY OF THE LATE LUIS A. OPEÑA, FORMER SANGGUNIANG BAYAN MEMBER OF THE THEN MUNICIPALITY OF TAGUM IN THE AMOUNT OF TEN THOUSAND (P10,000.00) PESOS.**

**WHEREAS,** it is the policy of the city government of Tagum to ensure that the welfare of its officials are always upheld;

**WHEREAS,** it is also the policy of the city government of Tagum to provide its officials not only moral but also financial and burial assistance during unavoidable circumstances such as sickness, injury, accident and death;

**WHEREAS,** LUIS A. OPEÑA, served as Sangguniang Bayan Member of the then Municipality of Tagum as Appointed Councilor from June to December 1987 and an Elected Councilor from January 1988 to June 1992;

**WHEREAS,** despite desolation and bereavement, the people of Tagum takes pride of his unwavering public service bestowed during his term as Sangguniang Bayan Member for five (5) uninterrupted years;

**WHEREAS,** the city government of Tagum resolved to provide funeral and burial assistance to the immediate family of the late LUIS A. OPEÑA in the amount of TEN THOUSAND (P10,000.00) PESOS to help them in their expenses;

**WHEREAS,** the source of funds shall be taken from the Awards and Indemnities;

**NOW THEREFORE,** be it resolved, as it is hereby resolved by the Sangguniang Panlungsod of Tagum to extend financial and burial assistance in favor of the family of the late LUIS A. OPEÑA, Former Sangguniang Bayan Member of the then Municipality of Tagum in the amount of Ten Thousand (P10,000.00) Pesos.
