RESOLUTION NO. 96, s- 2010

"A RESOLUTION GRANTING DEVELOPMENT PERMIT (DP) UNDER BP 220 TO IMACULADA CONCEPCION URBAN POOR HOMEOWNER'S ASSOCIATION, INC., AS REPRESENTED HEREIN BY MR. REYNALDO G. SIOSON, SR., FOR A SUBDIVISION CONTAINING AN AREA OF 20,000 SQUARE METERS, LOCATED AT BARANGAY CUAMBOGAN, TAGUM CITY."

WHEREAS, the Office of the City Mayor has endorsed the application of Imaculada Concepcion Urban Poor Homeowner's Association Inc. for approval of a subdivision of Development Plan which includes documents required in the process of development permit on August 24, 2010 to this August Body;

WHEREAS, the submitted subdivision plan satisfactory complied with the minimum requirements set in SEC. 10, Rule 111 of the Revised Implementing Rules and Standards Economic and Socialized Housing as manifested in the Local Zoning Board Site Inspection and Evaluation Report dated October 17, 2008;

WHEREAS, Paragraph 2 (x) Section 458 of Republic Act 7160, otherwise known as the Local Government Code of 1991 empowers the Sangguniang Panlungsod subject to the national law, to process and approve subdivision plans for residential, commercial or industrial purposes;

WHEREAS, it is incumbent upon this August Body to grant the Development Permit of the said applicant;

WHEREAS, be it resolved by the Sangguniang Panlungsod of Tagum to grant Development Permit under BP 220 to Imaculada Concepcion Urban Poor Homeowner's Association, Inc., containing an area of 20,000 square meters located at Barangay Cuambogan, Tagum City;

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum City, to grant Development Permit under BP 220 to Imaculada Concepcion Urban Poor Homeowner's Association, Inc., as represented herein by Mr. Reynaldo G. Sioson, Sr., for a subdivision containing an area of 20,000 square meters located at Barangay Cuambogan, Tagum City.
