**RESOLUTION NO. 83, s-2010**

**“A RESOLUTION AUTHORIZING THE CITY VICE MAYOR OF TAGUM, HON. ALLAN L. RELLON, MPA, TO ENTER INTO AND SIGN FOR AND IN BEHALF OF THE SANGGUNIANG PANLUNGSOD A CONTRACT OF SERVICE WITH THE BAYAN ANG GABAY – TELEVISION (BAG-TV 14) REPRESENTED BY ITS NETWORK MANAGER, MR. GILBERTO A. GORGONIO IN CONNECTION WITH THE TV PROGRAM FROM OCTOBER TO DECEMBER 2010.”**

**WHEREAS**, it is the right of every constituent in this City of Tagum to be informed of the Legislative measures and development initiatives of the Sangguniang Panlungsod and Local Government through various programs, projects and activities being legislated and implemented;

**WHEREAS**, in the light of recent developments of the locality there is a need for people to hear different opinions, especially from public officials-legislators for them to have extensive information and form insights about events and their significance in order for them to make objective decisions regarding their participation in the growth and development as an individual and community;

**WHEREAS**, aside from hearing news and information through other forms of mass media communication, the people who will watch local TV programs highlighting the practices implemented by the legislative department will have means of access to these programs, plans and other various activities that will benefit the entire populace through accurate information and could be possibly understood and to know what the legislative department has been doing in response to the needs of its constituency, react to certain policies and developments and be updated about programs and projects initiated by the Sangguniang Panlungsod of Tagum City;

**NOW THEREFORE**, be it resolved by the Sangguniang Panlungsod of Tagum to authorize the City Vice Mayor of Tagum, Honorable Allan L. Rellon, MPA, to enter into and sign for and in behalf of the Sangguniang Panlungsod a Contract of Service with the Bayan ang Gabay – Television (BAG-TV 14) represented by its Network Manager, Mr. Gilberto A. Gorgonio in connection with the TV Program from October to December 2010;

### **KNOW ALL MEN BY THESE PRESENTS:**

The **CONTRACT** is made and executed by and between:

The **BAYAN ANG GABAY TELEVISION (BAG-TV 14)**, represented by **Mr. Gilberto A. Gorgonio, Network Manager**, hereinafter called as the **PARTY OF THE SECOND PART**.

**WHEREAS**, it is the right of every citizen in this City of Tagum to be informed of the legislative measures and development initiatives of the Sangguniang Panlungsod through the various programs, projects and activities being legislated and implemented;

**WHEREAS**, in the light of recent developments of the locality there is a need for the people to hear different opinions, especially from public officials-legislators for them to have extensive information and form insights about events and their significance in order for them to make objective decisions regarding their participation in their growth and development as an individuals and community;

**WHEREAS**, aside from hearing news and information through other forms of mass media communication, the people who will watch local TV programs highlighting the 5<sup>th</sup> practices implemented by the legislative department and they will have means of access to these programs, plans and other various activities that will benefit the entire populace through accurate information and could be possibly understood and to know what the legislative department has been doing in response to the needs of its constituency, react to certain policies and developments and be updated about programs and projects initiated by the Sangguniang Panlungsod of Tagum City;

**WHEREAS**, the **PARTY OF THE FIRST PART** has chosen **PARTY OF THE SECOND PART**, considering its extensive information and localized TV network in Tagum City, the center for commerce in Davao del Norte;

**WHEREAS**, the **PARTY OF THE FIRST PART** is desirous to maximize Broadcast Media and provide the constituents of the city a tool and venue to interact and benefit from the city council's various plans and programs through an accurate dissemination of relevant information to the public through BAG-TV14 which will also serve to enable the public to know and contribute to the formulation by encouraging listeners/TV audience to react and send their signatures;

**WHEREAS**, the **PARTY OF THE SECOND PART** will broadcast the City Council's Regular Session;

**WHEREFORE**, in view of the foregoing premises, it is hereby agreed:

1. That the **PARTY OF THE SECOND PART** shall cover the City Council's Regular Session and Monday Convocation Program from October to December 2010 and will be aired in delayed telecast every Tuesday at 7:00 PM and replays every Wednesday to Sunday at 8:00 AM.
2. That for and in consideration of the said service, the **PARTY OF THE SECOND PART** shall receive a package payment in the amount of Forty-Five Thousand Pesos (P45,000.00) broadcast package inclusive;
3. That the coverage of the regular session shall be in accordance with the format of the program in which it is run. This will cover the City Council's Session;
