RESOLUTION NO. 1033, S-2010

“A RESOLUTION AUTHORIZING HONORABLE ALLAN L. RELLON, CITY VICE MAYOR OF TAGUM TO ENTER INTO AND SIGN FOR AND IN BEHALF OF THE SANGGUNIANG PANLUNGSOD A CONTRACT OF SERVICE WITH SUG’ANGAN NEWS NETWORK (SNN) – STV 10 SKYCABLE CHANNEL REPRESENTED BY ITS NETWORK MANAGER, MR. REY C. NAGAR IN CONNECTION WITH THE COVERAGE OF THE 4TH CITY COUNCIL’S REGULAR SESSION EFFECTIVE UPON ITS APPROVAL.”

WHEREAS, it is the right of every constituents in this City of Tagum to be informed of the programs' thrusts and legislations of the Sangguniang Panlungsod and the local government through various programs, projects being implemented;

WHEREAS, there is a need for people to hear different opinion, especially from public officials for them to have extensive information and form insights about events and their significance in order for them to make objective decisions regarding their participation in their growth and development;

WHEREAS, the Sangguniang Panlungsod of Tagum has chosen STV 10 Skycable, considering its extensive and localized network and as one of the widely respected, watched and patronized local cable TV stations in the City of Tagum;

WHEREAS, the Sangguniang Panlungsod of Tagum is desirous to maximize Tri-Media and provide the constituents of the city additional tool and venue to interact with the plans and programs of Sangguniang Panlungsod and the LGU as a whole;

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum to authorize Honorable Allan L. Rellon, City Vice Mayor of Tagum to enter into and sign for and in behalf of the Sangguniang Panlungsod a Contract of Service with Sug'angan News Network (SNN) – STV 10 Skycable Channel represented by its Network Manager, Mr. Rey C. Nagar in connection with the coverage of the 4th City Council's Regular Session effective upon its approval.

RESOLVED FURTHER, that the full text of the Contract of Service shall be as follows:

CONTRACT OF SERVICE

KNOW ALL MEN BY THESE PRESENTS:

The Contract is made and executed by and between:

The SANGGUNIANG PANLUNGSOD OF TAGUM, herein represented by the Honorable Allan L. Rellon, City Vice Mayor, hereinafter called as the PARTY OF THE FIRST PART;

The SUG'ANGAN NEWS NETWORK (SNN) - TAGUM, represented by Mr. Rey C. Nagar, Network Manager, hereinafter called as the PARTY OF THE SECOND PART.

WHEREAS, the Sangguniang Panlungsod is embarking on the massive information campaign in all various programs and project initiatives for the general welfare and information of the public;

WHEREAS, there is a need for people to hear different opinions, especially from public officials for them to have extensive information and form insights about events and their significance in order for them to make objective decisions regarding their participation in their growth and development as an individuals and community;

WHEREAS, the PARTY OF THE FIRST PART has chosen PARTY OF THE SECOND PART, considering its extensive information and localized Cable TV and Radio network in Tagum City, the center for commence in Davao del Norte;

WHEREAS, the PARTY OF THE FIRST PART is desirous to maximize television/radio broadcast and provide the constituents the venue to interact and participate in all programs and projects of the Sangguniang Panlungsod of Tagum City;

WHEREAS, the PARTY OF THE SECOND PART will broadcast the said programs with the same purpose in view:

WHEREFORE, in view of the foregoing premises, it is hereby agreed:

1. That the PARTY OF THE SECOND PART will air video coverage of the City Council's regular sessions and replay the same every Sunday 12 PM;
2. That for and in consideration of the said service, the PARTY OF THE SECOND PART shall receive a package payment in the amount of Fifteen Thousand Pesos (P 15,000.00) per month broadcast package inclusive and simultaneous live broadcast at 100.7 (Perfect 7) FM Radio Caritas;
3. That the broadcast of the radio/cable TV coverage shall be in accordance with the format of the program in which it is run (STV 10 and Radio Caritas Coverage of the 4th City Council Regular Session);
4. That this contract shall have a term of three (3) months from January 2010 to March 2010.
