RESOLUTION NO. 1045, s-2010

A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF TAGUM THROUGH HON. REY T. UY, CITY MAYOR, IN THE UTILIZATION OF THE 5% CALAMITY FUND OF THE ANNUAL BUDGET 2010 FOR UNDERTAKING INFRASTRUCTURE SUPPORT ACTIVITIES INCLUDING THE CONSTRUCTION AND REHABILITATION OF DRAINAGE CANALS DISASTER PREPAREDNESS ACTIVITIES AND OTHER MITIGATING MEASURES TO PROTECT THE CITY AND ITS CONSTITUENCY FROM IMMINENT DANGER OR CALAMITIES AND OTHER DISASTER OCCURENCIES.

WHEREAS, pursuant to Article 3 (d) of the Implementing Rules and Regulations of the Local Government Code of 1991, provides that Local Government Unit shall exercise the powers expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare and safety of its constituency;

WHEREAS, Tagum City is generally a low-lying area and is annually affected with floods causing wide range destruction to public and private property;

WHEREAS, pursuant to the IRR of the Local Government Code of 1991, our Local Government Unit has also the inherent responsibility of protecting its constituency from the effects of calamity, terrorism and other disasters which may endanger their lives and destroy properties;

WHEREAS, Joint Memorandum Circular No. 1, s-2003 dated March 23, 2003 of the Department of Budget and Management, Department of the Interior and Local Government further confirms on the utilization of such calamity fund for pre-disaster needs and other mitigating measures;

WHEREAS, one of the thrusts of the City Government of Tagum is the provision of infrastructure support including the construction and rehabilitation of main drainage canals, other mitigating projects, disaster preparedness activities, and emergency measures in order to provide utmost security and promote the welfare and safety of its constituency;

WHEREAS, the City Government of Tagum is executing the necessary precautionary and mitigating measures and disaster activities to avoid the loss of lives and damage to properties;

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum to authorize the City Government of Tagum through Hon. Rey T. Uy, City Mayor, in the utilization of the 5% calamity fund of the annual budget 2010 for undertaking infrastructure support activities, including the construction and rehabilitation of drainage canals, disaster preparedness activities and other mitigating measures to protect the city and its constituency from imminent danger or calamities and other disaster occurrences;

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and guidance.
