A RESOLUTION CONGRATULATING MARK EFHRAEM "JIPOY" DALMAN, A FOURTH YEAR STUDENT OF TAGUM CITY COMPREHENSIVE NATIONAL HIGH SCHOOL & A SULONG-DUNONG GRANTEE OF THE OFFICE OF THE CITY VICE MAYOR FOR HAVING BROUGHT HONOR AND PRESTIGE TO TAGUM CITY FOR BEING ADJUDGED AS ONE OF THE TEN OUTSTANDING PUBLIC SCHOOL STUDENTS IN THE PHILIPPINES FOR THE 4TH VICE PRESIDENT NOLI DE CASTRO ACADEMIC EXCELLENCE AND EXEMPLARY LEADERSHIP AWARDS.

WHEREAS, a Regional Search for 4th Vice President Noli de Castro Excellence and Exemplary Leadership Awards for the Ten Outstanding Public School Students was conducted last January 15, 2010 at Davao City and out of 1,000 applicants Mark Efhraem Dalman proclaimed one of the three finalists for Mindanao to compete in the national level;
