**RESOLUTION NO. 206, s-2011**

**“A RESOLUTION REQUESTING THE LAND TRANSPORTATION OFFICE (LTO) AND OTHER GOVERNMENT AGENCIES CONCERNED TO HOLD IN ABEYANCE THE IMPLEMENTATION AS TO THE CHANGING OF COLOR OF MOTORCYCLE-FOR-HIRE (MCH) IN THE CITY OF TAGUM.”**

**WHEREAS**, the attention of some members of this august body has recently been called as regards the colors of tricycle units that are reflected on LTO records;

**WHEREAS**, by virtue of CTRFB Resolution No. 1, s-2005 and Executive Order No. 20, s-2008, all Motorized Tricycles for Hire operating in the territorial jurisdiction of Tagum City have been painted Apple Green, patterned after the color of the City Logo;

**WHEREAS**, the disparity between the color reflected on LTO records which is that of the motorcycle unit, and the body color of the tricycle unit has been noted by the LTO – District Office;

**WHEREAS**, cited by the LTO – District Office as needing compliance on the part of the MTH operators in the City of Tagum was LTO Memorandum dated 09 march 2010 wherein it was emphasized that the most dominant color of a motor vehicle/motorcycle should be the one indicated in LTO records, hence in the case of the city's MTH units, apple green;

**WHEREAS**, applying for change color, i.e. to reflect green as the unit color in LTO records requires several documents and concomitantly, entails some expenses;

**WHEREAS**, although MTH operators in the city have expressed willingness to comply with the LTO's memorandum, the expenses that will go along with it are just too much for them to bear at this point; hence their request to have it implemented some other time;

**NOW THEREFORE**, be it resolved by the Sangguniang Panlungsod of Tagum to request the Land Transportation Office (LTO) and other Government Agencies concerned to hold in abeyance the implementation as to the changing of color of Motorcycle-For-Hire (MCH) in the City of Tagum.

**RESOLVED FURTHER**, that copies of this resolution be furnished to the Land Transportation Office (LTO) and to all offices concerned for information and guidance.
