**WHEREAS**, it is also the policy of the City Government of Tagum to provide its officials not only moral but also financial and burial assistance during unavoidable events such as sickness, injury, accidents and death;

**WHEREAS**, Pacifico C. Labastida served as Barangay Kagawad of Barangay New Balamban for Three (3) years;

**WHEREAS**, Pacifico C. Labastida suffered cardiac arrest which caused his death;

**WHEREAS**, the City Government of Tagum resolved to provide funeral and burial assistance to the immediate family of the late Pacifico C. Labastida in the amount of Ten Thousand Pesos (P10,000.00) to help them in their expenses;

**WHEREAS**, the source of funds shall be taken from the Mayor's Office MOOE and Donation;

**NOW THEREFORE**, be it resolved by the Sangguniang Panlungsod of Tagum to extend funeral and burial assistance in favor of the family of the late Pacifico C. Labastida, Barangay Kagawad of Barangay New Balamban in the amount of Ten Thousand Pesos (P10,000.00).
