**RESOLUTION NO. 229, s- 2011**

**“A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. REY T. UY, TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF TAGUM, THE DEED OF ABSOLUTE SALE OF LOT 12, CCS-11-001123 COVERED AND EMBRACED BY THE ORIGINAL CERTIFICATE OF TITLE NO. P-50358 REGISTERED IN THE NAME OF SANTA SARONA, SITUATED IN BARANGAY SAN AGUSTIN, TAGUM CITY TO BE UTILIZED AS REFORESTATION AND WATERSHED AREA OF THE CITY GOVERNMENT OF TAGUM.”**

**WHEREAS**, the City Government of Tagum desires to purchase a parcel of land with an aggregate area of One Hundred Thirty-Five Thousand One Hundred Seventy-Nine (135,179) square meters more or less to be utilized as planting area of trees in support to the clean and green program of the national government and for other purposes that the City Government may deem necessary;

**WHEREAS**, Santa Sarona, in her letter on September 27, 2010 addressed to the Honorable Mayor, signify her intention to sell her property identified as lot 12, Ccs-11-001123 with an area of 3,462 square meters, covered and embraced by Original Certificate of Title No. P-50358 located in Barangay San Agustin, Tagum City;

**WHEREAS**, one way of supporting the national government's effort of greening the country, the city government sees the urgent need to plant trees to the denuded forest in the rural areas;

**WHEREAS**, the present administration priority program is geared towards the upliftment and security of the inhabitants of Tagum in pursuance to the vision for progress and prosperity, the City Government is considering the amount of One Hundred Twenty-One Thousand One Hundred Seventy (P121,1707.00) Pesos for land acquisition;

**WHEREAS**, on December 2, 2010, the City Appraisal Committee submitted its appraisal report with the recommendation that the market value for Lot 12, Ccs- 11-001123 with an area of 3,462 square meters, covered and embraced by Original Certificate of Title No. P-50358 is Thirty Five ( P35.00 ) Pesos per square meter or a total of P121,170.00 Pesos;

**WHEREAS**, funding of this project is already appropriated in the regular budget as certified by the office of the City Budget Officer;

**WHEREAS**, considering that all the necessary supporting documents are already in placed, it is just proper and appropriate that the purchase of the aforementioned property be now acted favorably with dispatch;

**NOW THEREFORE**, be it resolved by the Sangguniang Panlungsod of Tagum to authorize the City Mayor, Hon. Rey T. Uy, to sign for and in behalf of the City Government of Tagum, the Deed of Absolute Sale of Lot 12, Ccs 11-001123 covered and embraced by original Certificate of Title No. P-50358, registered in the name of Santa Sarona, situated in Barangay San Agustin, Tagum City to be utilized as reforestation and watershed area of the City Government of Tagum.

**RESOLVED FURTHER**, that the full text of the Deed of Absolute Sale shall be read as follows:

**DEED OF ABSOLUTE SALE**

**KNOW ALL MEN BY THESE PRESENTS:**

This **DEED**, made and executed in Tagum City, Philippines, by and among:

**SANTA SARONA**, of legal age, Filipino, widow and a resident of Barangay San Agustin, Tagum City, Davao Del Norte, Philippines, hereinafter known and referred to as the **VENDOR**;

The **CITY GOVERNMENT OF TAGUM**, a public corporation with office address at Rizal St., Tagum City, Philippines, represented herein by the City Mayor, **HON. REY T. UY**, likewise of legal age, Filipino, married and a resident of Tagum City, hereinafter known and referred to as the **VENDEE**.

WITNESSETH: That

The **VENDOR** is the registered owner of a certain parcel of land situated in Barangay San Agustin, Tagum City, Province of Davao del Norte, Philippines, particularly known as Lot 12, Ccs-11-001123 containing an area of 3,462 square meters and the same is covered and embraced by Original Certificate of Title No. P-50385 and more particularly described as follows:

**NOW THEREFORE**, for and in consideration of the sum of ONE HUNDRED TWENTY-ONE THOUSAND ONE HUNDRED SEVENTY (P121,170.00) PESOS, Philippine Currency, receipt of which is hereby acknowledged by the **VENDOR**, to her entire satisfaction, by these presents do hereby **SELL, TRANSFER, and CONVEY** in a manner absolutely and irrevocably unto the said **VENDEE** their assignees and successors-in-interest of the above-described parcel of land together with all the improvements from thereon free from all liens and encumbrances.

The **VENDOR** now warrants the peaceful possession of the property by the **VENDEE** or her duly authorized representative.
