RESOLUTION NO. 283, s-2011

“A RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 01, SERIES OF 2011 OF THE SANGGUNIANG BARANGAY OF MAGUGPO POBLACION, TAGUM CITY, OPERATIVE EFFECTIVE UPON ITS APPROVAL.”

WHEREAS, forwarded to this august body is Supplemental Budget No. 01 of Barangay Magugpo Poblacion, Tagum City as authorized by the Sangguniang Barangay under Appropriation Ordinance No. 01, s-2011, appropriating the sum of **One Million Eight Hundred Thirty-Four Thousand Nine Hundred Sixty Pesos and 84/100 (P1,834,960.84)**, for appropriate action;

WHEREAS, per evaluation pursuant to Section 333 of the Local Government Code of 1991 otherwise known as Republic Act No. 7160, it was found to have substantially complied with the provision of law;

WHEREAS, this august body deems it proper to declare operative said Appropriation Ordinance, subject however to the following conditions:

1. That all applicable accounting and auditing rules and regulations in the disbursement of funds released by the barangay shall be strictly observed.
2. That the responsibility for the execution of this Supplemental Budget and the accountability therefor shall be vested primarily to the Local Chief Executive.

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum to declare Appropriation Ordinance No. 01, series of 2011 of the Sangguniang Barangay of Magugpo Poblacion, Tagum City, operative effective upon its approval, subject however to the conditions stated above.

RESOLVED FURTHER, that copies of this resolution be furnished to the Sangguniang Barangay of Magugpo Poblacion, Tagum City and to all offices concerned for their information and record.
