RESOLUTION NO. 305, s- 2011

"A RESOLUTION WAIVING THE CITY GOVERNMENT OF TAGUM'S CLAIM OVER THE SCHOOL SITE OF SALVACION ELEMENTARY SCHOOL IN FAVOR OF THE MUNICIPALITY OF MAWAB, COMPOSTELA VALLEY PROVINCE."

WHEREAS, the school site of Salvacion Elementary School located in Mawab, Compostela Valley Province was surveyed in the name of the then Municipal Government of Tagum specially during the then undivided Municipality of Tagum wherein Mawab was still part of the city's territorial jurisdiction;

WHEREAS, with the favorable endorsement of the then Municipal Council of Tagum headed by Mayor Herminigildo Baloyo and with the favorable support of then Assemblyman Gavino Sepulveda and Senator Alejandro Almendras, Mawab was formally created into a regular municipality being one of the requirements in the issuance of the Reservation of School sites thru a Presidential Proclamation in favor of the Department of Education;

WHEREAS, the Sangguniang Bayan of the Municipality of Mawab, through its letter dated January 14, 2011, is requesting for a passage of a Resolution formally awarding the school site to the said municipality being one of the requirements in the issuance of Reservation of School sites thru Presidential Proclamation in favor of the Department of Education;

WHEREAS, finding the request to be proper and in accordance with law, it is incumbent upon this august body to waive the City Government of Tagum's claim over the school site of Salvacion Elementary School in favor of the Municipality of Mawab, Compostela Valley Province.

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod to waive the City Government of Tagum's claim over the school site of Salvacion Elementary School in favor of the Municipality of Mawab, Compostela Valley Province.

RESOLVED FURTHER, that copies of this resolution shall be furnished to the Sangguniang Bayan of Mawab, Compostela Valley Province for their information and records.
