RESOLUTION NO. 310, s-2011

“A RESOLUTION TRANSFERRING/DONATING THE AMOUNT OF ONE HUNDRED SIXTY THOUSAND (P160,000.00) PESOS TO THE PROVINCIAL GOVERNMENT OF COMPOSTELA VALLEY FOR THE GAWAD KALINGA FOUNDATION, INC., TO BE USED FOR THE CONSTRUCTION OF TWO (2) UNITS LOW COST HOUSING FOR THE UNDERPRIVILEGED BROTHERS AND SISTERS IN COMPOSTELA VALLEY.”

WHEREAS, this said transfer/donation is in line with the previous Resolution No. 91, s-2007 authorizing the Tagum City Mayor Rey T. Uy to enter into and sign for and in behalf of the City of Tagum a Memorandum of Partnership Agreement with the Gawad Kalinga Foundation, Inc., for the implementation of their programs;

WHEREAS, Compostela Valley Provincial Government and the Gawad Kalinga Foundation, Inc., are Tagum City's partners in the execution of its many projects;

WHEREAS, Gawad Kalinga Foundation, Inc., is a non-profit organization that is known to, and aims, to help the underprivileged brothers and sisters in the different communities in the Philippines;

WHEREAS, Tagum City is one government organization that believes in the said foundation's capabilities and transparency in its operations;

WHEREAS, Gawad Kalinga Foundation, Inc., needs additional support from the different government agencies and non-government organizations to be able to realize their vision;

WHEREAS, the said amount of donation shall be taken from the Shelter Assistance Program under the Locally Funded Projects of the City of Tagum and be transferred to the Provincial Government of Compostela Valley and be passed on to the Gawad Kalinga Foundation, Inc.;

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum to transfer/donate the amount of One Hundred Sixty Thousand (P160,000.00) to the Provincial Government of Compostela Valley for the Gawad Kalinga Foundation, Inc., to be used for the construction of two (2) units low cost housing for the underprivileged brothers and sisters in Compostela Valley.

RESOLVED FURTHER, that copies of this resolution shall be furnished to the Provincial Government of Compostela Valley and Gawad Kalinga Foundation, Inc., and to all offices concerned.
