RESOLUTION NO. 315, s-2011

“A RESOLUTION REQUESTING HONORABLE NELSON P. LALUCES, CHAIRMAN, LAND TRANSPORTATION FRANCHISING AND REGULATORY BOARD (LTFRB) TO PUT UP A SATELLITE OFFICE IN TAGUM CITY.”

WHEREAS, the provision for the welfare of the local residents is within the inherent power of the state as embodied under Section 16 of the Local Government Code;

WHEREAS, Section 17 of Republic Act 7160 provides that the Local Government shall endeavor and shall exercise powers and discharge such other functions and responsibilities as necessary, appropriate or incidental to efficiently and effectively provide of the basic services and facilities;

WHEREAS, years ago LTFRB used to have a satellite office in the city but for unknown reason it was pulled out;

WHEREAS, putting up an office again is necessary considering that Tagum City is progressing and the needs of the transport sector, which has a total population of two hundred twenty five thousand (225,000.00), is also increasing;

WHEREAS, such a move in the city will improve public service and as well as bring the government closer to the people;

WHEREAS, transactions that involve franchising will be facilitated just within a day in lesser number of hours once the office will be put up in the city;

NOW THEREFORE, BE IT RESOLVED by the Sangguniang Panlungsod of Tagum City to request Honorable Nelson P. Laluces, Chairman, Land Transportation Franchising and Regulatory Board (LTFRB) to put up a satellite office in Tagum City.

RESOLVED FURTHER, that copies of this resolution shall be furnished to the Office of the Honorable Nelson B. Laluces and to the Office of the LTFRB Region XI.
