“A RESOLUTION APPROVING THE APPLICATION FOR ACCREDITATION OF CITY OF TAGUM TOURISM COUNCIL AS NON-GOVERNMENT ORGANIZATION IN THIS CITY.”

WHEREAS, Article 62, Rule XII of the Implementing Rules and Regulations of the Local Government Code of 1991 provides that the LGU shall promote the establishment and operation of people's organizations, non-government organizations and the private sector to make them active partners in the pursuit of local autonomy;

WHEREAS, in furtherance of law and policy relative to the participation of non-government organizations in the promotion of the participatory local governance and in the pursuit of local autonomy, DILG MC No. 2001-89 provide for the guidelines and procedure in the accreditation;

WHEREAS, the City of Tagum Tourism Council is the focal event organizer for Meetings, Investments, Conferences, Exhibitions (MICE) programs and projects of the city and to address the institutionalization of the organization in the local tourism development of Tagum City, the City of Tagum Tourism is in need to be affiliated and accredited in local and national organizations and government institutions that would entail updates, support, enhancement and development for the association;

WHEREAS, the City of Tagum Tourism Council, created by virtue of City Ordinance No. 35 series of 1998 as legitimate non-government organization implementing tourism, arts and culture programs shall apply for accreditation as NGO in the City Government of Tagum;

WHEREAS, after thorough review of the documents submitted to this august body per Committee Report No. 1, s-2011, the City of Tagum Tourism Council is fit for accreditation as Non-Government Organization in this city;

NOW THEREFORE, be it resolved by the 5th City Council of Tagum to approve the application for accreditation of City of Tagum Tourism Council as Non-Government Organization in this city.

RESOLVED FURTHER, that copies of this resolution be furnished to City of Tagum Tourism Council and to all offices concerned for their information and guidance.
