RESOLUTION NO. 332, s-2011

“A RESOLUTION OPPOSING THE PRIVATIZATION OF THE AGUS AND PULANGI HYDRO POWER PLANTS IN MINDANAO.”

WHEREAS, the Agus and Pulangi Hydropower Plants located in the City of Iligan and Province of Bukidnon respectively supply more than fifty percent (50%) of the total consumption in Mindanao;

WHEREAS, the privatization will result to uncontrollable cost since a new owner will surely recover his investments by imposing increase of rates and in a fashion more disadvantageous to the end-users;

WHEREAS, the present power rate of the Agus and Pulangi Power Plants is less than one peso (P1.00) per kilowatt hour compared to other power plants;

WHEREAS, privatization of the said power plants will endanger and exacerbate hostility to the hydro plants of the people in the communities adjacent to Lake Lanao and to the Agus and Pulangi Rivers and the rest of the marginalized consumers and such magnify problems on security and peace;

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod of Tagum to oppose the privatization of the Agus and Pulangi Hydropower Plants in Mindanao.

RESOLVED FURTHER, that copies of this resolution shall be furnished to the Office of the President, Department of Energy, House of Representatives, Senate and other offices concerned for information and guidance.
